## TOZAI NIKKEI RULES AND REGULATIONS

- This tournament shall be governed by the rules and regulations of the United States Bowling Congress (USBC) with the exception of the below mentioned rules which apply to all entrants. The fee for unattached USBC membership is \$25.00. Bowlers must be certified USBC members in order to receive USBC awards. Non-USBC members may bowl without high score protection.
- The tournament opens Saturday, October 19, 2019 and closes Sunday, October 20, 2019 and will be held at Fountain Bowl in 2.
- Entry deadline is Tuesday, October 1, 2019. Late entries will be accepted based on squad availability. Entry fees must accompany 3. entry forms. Incomplete entries or entries submitted without total fees will be returned. Make check(s) payable to: Tozai Nikkei.
- All entries will be scheduled in the order they are received. Out of town bowlers will be given squad preference if their entry is received by the deadline date. Out of town bowlers are those residing outside the Orange and greater Los Angeles county areas and are required to submit their averages verified by a league secretary or their local bowling association prior to the start of the 5.
- Eligibility rules are as follows:
  - All persons with Japanese ancestry.
  - Any non-Japanese person married to 'A' above.
  - Any non-Japanese person who is a current SCNBA member.
  - All participants of any past Tozai Nikkei Bowling Tournament.
- The committee also reserves the right to assign bowler(s) to another squad if the requested squad is filled. Second (2<sup>nd</sup>) choices will be honored whenever possible. 7.
- All bowlers must check-in 30 minutes prior to their scheduled squad time.
- In the event a bowler cannot bowl, he/she may name a qualified substitute 30 minutes prior to scheduled squad time. No entry fee will be refunded to absent bowlers.
- Bowlers must bowl in the order listed. Substitutes must bowl in the position of the original entrant.
- 10. Late bowlers MUST bowl from the frame in progress and all missing frames will be counted as zero (0).
- Tournament entering average shall be based on the highest of the last two years:
  - 2018-2019 published average as of May 31, 2019. If none, use (b).
  - 2017-2018 published average as of May 31, 2018. If none, use (c) or (d).
  - c. Highest current 2019-2020 winter season average of 21 games or more. (Must submit league sheet for verification.)
  - d. If none of the above, entrant must use scratch average of 230.
- 12. SPORT AVERAGES: All Sport Averages WILL COUNT regarding your highest book average and will be converted using the U.S.B.C. sport average conversion chart.
- 13. Any member of any professional organization will bowl scratch in all tournament events. Upon releasing their pro card, there will be a period of twenty-four (24) months following that he/she will continue to bowl scratch.
- 14. Handicap shall be 90% of 230 for both men and women. Minimum entering average is 135 for women and 160 for men and 125 for senior women and 150 for senior men in SENIOR event only. All entrants with averages exceeding 230 will receive 0 for their
- 15. USBC Rule 319A-1, 3 & 5 shall be in effect. USBC Rules 319A-2 & 4 are waived.
  - a. It shall be the bowler's sole responsibility to verify the accuracy of his/her average, whether originally submitted by the bowler
  - A bowler shall be disqualified (from the squad) if their submitted average is lower than their actual average and the proper correction is not completed prior to the completion of the first game. If the submitted average is higher than the actual average and the proper correction is not completed prior to the completion of the first game, the higher average will be used for that squad. All corrections are to be done by tournament officials only.
- 16. A bowler who has qualified for winnings of \$200.00 or more in any tournament within the previous 12 months must report actual scores, position and amount won to the tournament committee at the time of entry for possible re-rate.
- 17. USBC Rule 319E shall be in effect. The tournament committee reserves the right to re-rate any bowler. Re-rated bowlers will be notified seven (7) days prior to start of tournament. If the assigned re-rate average is not accepted by the bowler, entry fee shall be
- A bowler who is re-rated by any tournament (whether accepted or not) must report the re-rate average when submitting entry. Rerate average will be used for 24 months from the originating tournament such average was established.
- An Open Team consists of five (5) bowlers, in any combination of men and women with a USBC membership card. Team can be all women. A Mixed Team consists of two men and two women. Each bowler may enter MULTIPLE Mixed Doubles events, but may cash only ONCE with each partner. A "Senior" is defined as a woman, 50 years and older, and a man age 55 years and older. Prize fund will be returned 100%. Prior to any prize distribution, the tournament committee has the right to verify averages with all
- Any scoring disputes must be brought to the attention of a committee member before the end of the game in question. The tournament committee has the final decision on all concerns of the tournament. Failure to comply with any of the above rules and regulations shall be cause to forfeit all entry fees and prize monies.
